

AUDITORS' REPORT :

We have audited the attached Balance Sheet of "BINOBA AROGYA EVAM LOK SHIKSHAN KENDRA: JAIKRISHNA NAGAR: BARAI: ISLAMPUR: NALANDA [BIHAR]" as at 31st March, 2019 and attached (Consolidated) Income & Expenditure account as well as (Consolidated) Receipts & Payments Account for the year ended on that date prepared on the basis of scheme wise audited statements of earlier date read with observations given hereunder give true and fair view of the state of affairs of the Institutions and are in agreement with the books of account produced before us.

OBSERVATIONS :

1. Audit of a project funded by CASA have been audited by another firm of Chartered Accountants as per agreement between the CASA and the firm.
2. Physical verification of Fixed assets was carried out by the Management after the close of the Financial Year. We also reviewed the system of verification. In the process of verification there was no discrepancy in between book records and actual verification.
3. Some of the items of Income & Expenditure are on cash basis.
4. Some of the Misc. Fixed assets and Dead stock (As per item L Schedule 'D') which were acquired/ purchased during last several years do not have any Reserve Fund there against. It is also informed that their value stand fully utilized in course of use in past several years and their present realizable value may not fetch any considerable amount; However, the depreciation is being charged as prescribed.
5. Sanitation Programme of CAPART is non functional. However, Opening & Closing Balance of Rs. 723.56 is being carried out from year to year. The matter should be brought to the notice of CAPART management for write off / adjustment.
6. Grant Receivable from NFE of Rs. 0.76 lacs appears doubtful. It requires follow-up measures for necessary adjustment, if needed.
7. Unrealized amount of grant amounting to Rs. 63.00 may be adjusted with SBI which is pending for a long time.
8. Grant in Aid receivable in General Account is being carried over from year to year and possibility of realization is bleak. The management should decide the unrealizable grant fund.
9. Amount received from BVHS Rs. 1,313/- and CPSL Rs. 9,226/- are coming since last many years in General Account. As such they need proper adjustments/ write off against grant in aid receivable (considered doubtful).

10. Medicine stock fund appearing on both side of Balance Sheet Rs. 54,705.00 coming since many years may be adjusted as per contra, as those must have become time barred.
11. Rehabilitation fund of Rs. 1,30,720.00 may have become irrelevant as on date since it is being carried forward since long.

N.B.: One cheque bearing no. 395641 dt. 4.3.2019 of FCRA Bank Account No. 33127 of SBI, Islampur amounting to Rs. 37,500/- was issued for payment to the coordinator of CASA Project Sri Anjay Kumar, but bank has wrongly credited to payees Account only Rs. 35,700/- on 6.3.2019 (Less Rs. 1,800.00), As such balance of bank is subject to a difference of Rs. 1,800/-.
